2020-2021 Eclectic Motorworks Storage Agreement

Eclectic Motorworks (hereinafter EMW) and the above-noted vehicle owner hereby agree, as follows:

- 1) This agreement is for storage only and applies only to the above-described vehicle and owner.
- 2) The storage fee at the above-noted monthly rate shall be payable A) in full in advance or B) in advance on the first day of each and every month at the EMW premises in person or by mail throughout the storage period. In the event storage does not commence on the first of the month, then the first month storage fee shall be pro-rated and paid at storage commencement together with the next full month storage fee. Thereafter, storage fees shall be paid, in advance, on the first day of each month.
- 3) Fees paid more than ten (10) days after the first of each month are subject to a \$15 service charge.
- 4) EMW shall exercise normal and reasonable care over the vehicle during the storage term; however, storage of the vehicle shall be at the sole risk of the owner. EMW shall not be liable for fire, storm, or other catastrophic damage, nor shall EMW be liable for theft or vandalism of any kind to the vehicle, its contents or other equipment. All non-vehicle personal property shall be removed from the vehicle by the owner prior to storage of the vehicle.
- 5) Upon commencement of the storage period the owner shall provide to EMW written proof of insurance for the vehicle, and shall carry, at a minimum, comprehensive insurance coverage which shall be the primary vehicle damage or loss coverage during the storage term. EMW shall provide normal insurance coverage for the premises. Vehicle owner and EMW hereby waive all rights of subrogation for insured losses and each agrees to rely solely upon its own respective insurance carriers for any and all loss coverage.
- 6) Vehicle owner and its designees agree to fully comply with all written or posted storage and repair shop rules and regulations.



- 7) Owner acknowledges that antique, classic or other vehicles tend to leak oil, grease, anti-freeze, brake and transmission fluids and other slippery substances which can easily cause persons to slip or fall and sustain severe injuries, therefore, owner and owner's guests or designees enter the garage and storage area solely at their own and owner's risk and shall enter only when accompanied by an EMW employee. EMW makes no warranty as to the condition of the floors and walkways and EMW shall have no responsibility or liability for injury to persons or their property while on the premises.
- 8) Oily rags and other flammable materials, except for vehicle fuel inside a normal, approved fuel tank, must be removed from the vehicle and the premises prior to storage. Batteries shall be disconnected to reduce the risk of fire or other damage to the vehicle and/or the premises.
- 9) EMW shall have the right to move the vehicle as EMW, at its discretion, may deem necessary from time to time. Only EMW employees and agents may enter into or move/drive the vehicle inside the premises during the storage term. Owner agrees to leave one (1) of each key necessary to unlock and operate vehicle with Eclectic Motorworks for the duration of storage.
- 10) The storage area is not a workshop. Neither the owner nor other owner designated persons may perform repairs or maintenance operations to the vehicle while in the storage or other areas of the storage premises.
- 11) EMW will monitor and maintain battery charge and tire pressures during storage. Fluids will be monitored as well, however the owner is responsible for the costs of any additional fluids being added to the vehicle during storage.

REMOVAL FROM STORAGE: Owner shall provide EMW with written or verbal notice at least three (3) days prior to removal from storage. EMW shall not release the vehicle to the owner or the owner's designee until all storage fees are paid in full, as well as any additional amounts owing for prior authorized repair or maintenance services to the vehicle which are unpaid.

In-and-Out storage service is available with at least one (1) full day's notice. Current storage charges must be paid in full to receive in-and-out service.
